## Introduction

Key Themes and Findings: Understanding Climate Denial and Delayism in Canada

This report examines how climate denial and delayist narratives circulate in Canada's digital ecosystems, shaping public opinion, fuelling polarisation, and constraining democratic capacity to respond to environmental challenges. Drawing on original research and online analysis, it documents how adversarial climate rhetoric operates and where it intersects with other harmful narratives. Together, these narratives frame climate action as illegitimate, costly, or part of a broader cultural and political agenda threatening Canadian values and sovereignty.

Climate denialism frequently overlaps with broader conspiracy theories. Narratives suggest that climate policy is a tool of global elites, often invoking international organisations or Canadian federal authorities as instruments of control. These discourses depict progressive environmental measures as designed to undermine national independence and impose restrictions on ordinary citizens, echoing grievances linked to pandemic-related policies. In this way, denialist rhetoric draws strength from existing distrust in government, international institutions, and scientific expertise.

Importantly, disinformation does not circulate uniformly across Canada. Regional vulnerabilities are shaped by economic, cultural, and political factors. Provinces with deep reliance on fossil fuel industries and histories of tension with federal environmental regulation, particularly Alberta, Saskatchewan, and Manitoba, exhibit greater receptivity to climate denial and delayist narratives. By contrast, Quebec and Atlantic provinces tend to show more substantial support for climate action and greater resilience against disinformation. These regional divergences illustrate how adversarial actors tailor their messaging to exploit local anxieties, from economic security to provincial sovereignty, ensuring that climate disinformation resonates differently across Canada's information environment.

A further feature of the Canadian climate denial ecosystem is the targeting of activists themselves. They are vilified as "cultists," criminals, or even terrorists, particularly during moments of crisis such as the 2023–24 wildfire seasons. This rhetoric shifts debate away from policy toward personal attacks, normalises hostility, and in some cases echoes organised campaigns by fossil fuel–aligned actors. By discrediting activists through misogynistic, anti-2SLGBTQIA+, and conspiratorial frames, adversarial narratives delegitimise advocacy and discourage civic engagement.

Political figures, feminists, 2SLGBTQIA+ people, and prominent climate activists such as Greta Thunberg are targeted with harassment that delegitimises their credibility and expertise through gendered and identity-based attacks. Immigration is repeatedly reframed as an environmental threat, portraying newcomers as primary contributors to greenhouse gas emissions and as a justification for calls to restrict immigration. In doing so, climate denialism functions as a vehicle for the spread of broader exclusionary and conspiratorial ideas. These dynamics illustrate how climate disinformation rarely circulates in isolation. Instead, it often travels with anti-feminist, anti-queer, antisemitic, and anti-immigrant tropes, laundering prejudice through debates about science and policy.

The sections that follow provide a deeper analysis of the narratives, actors, and ecosystems sustaining climate denial and delayism in Canada. Before turning to those, this introduction outlines which audiences are targeted by denialist rhetoric, who experiences its impacts most directly, and how these narratives shape the broader information environment.

Demographics and Exposure: Who Is Targeted By Adversarial Climate Narratives

Climate denial and delayist narratives in Canada are aimed at several distinct audiences.

- Middle and working class voters are told that climate policies will impose unaffordable costs or restrict their mobility, framing environmental action as an economic threat to households.
- Groups with low trust in state institutions are primed to see climate science and government policy as manipulative or illegitimate.
- Communities angered by COVID-19 measures are targeted with rhetoric suggesting climate action will bring similar restrictions on freedom, such as "climate lockdowns" or prison-esque "15-minute" cities.
- Conservative voters are repeatedly presented with frames that depict climate policy as part of a progressive cultural agenda imposed from above.

The impacts of these narratives extend beyond their target groups. Holders of public office across Canada are encountering increasingly aggressive resistance to climate policies, from the federal level to municipal councils. Scientists researching climate change face hostility and



distrust, weakening public engagement with scientific expertise. Climate activists are subjected to harassment, often grounded in misogynistic or anti-2SLGBTQIA+ rhetoric, which undermines their safety and limits their participation in public discourse.

Hostility against disaster relief officials in the United States, fuelled by conspiracies about engineered disasters and land grabs, has already led to aggressive actions during hurricanes and floods.<sup>3</sup> While this dynamic is less visible in Canada, the porous digital environment makes it likely that such narratives will spill across the border, especially as Canadian extremist communities engage closely with US counterparts.

Another longer-term consequence of climate denialist narratives is the erosion of public space for reasoned debate. By framing climate policy as conspiratorial or oppressive, adversarial actors reduce the possibility of meaningful discussion about how costs, taxation, or lifestyle adjustments should be shared across Canadian society. This distortion of democratic deliberation has enduring consequences for the legitimacy and effectiveness of climate policy.

### **Key Actors**

The Canadian climate denial and delayist ecosystem is shaped by a mix of domestic outlets, political figures, online influencers, and fringe platforms that recirculate and amplify adversarial narratives. These actors operate across a hybrid information space in which conspiratorial and bigoted rhetoric is interwoven with climate disinformation, enabling extremist tropes to move fluidly between online communities and mainstream debates.

#### **Domestic Media Outlets**

Websites such as Rebel News and True North have consistently published content minimising or denying climate change while framing climate action as part of a broader "globalist" agenda. Coverage often overlaps with anti-2SLGBTQIA+, anti-immigration, and anti-feminist narratives, reinforcing a worldview in which environmental policy is a threat to Canadian sovereignty and cultural identity.

#### **Influencers and Public Figures**

Prominent Canadian commentators and online personalities serve as bridging actors, linking fringe denialist content with larger audiences. They frequently frame climate science as "politicised" and use gendered or conspiratorial language to discredit climate activists. These influencers also amplify transnational networks by aligning themselves with US and European denialist voices, adapting foreign narratives for a Canadian context.

#### **Fringe Platforms and Communities**

Substack newsletters, Telegram channels, and niche online forums host more extreme denialist

content, including antisemitic and "Great Replacement" conspiracies tied to environmental issues. These communities depict climate change as a hoax designed to justify population control, connect denialist rhetoric with opposition to immigration, and frame progressive climate policies as deliberate attempts to undermine "founding" populations in Canada.

#### **Transnational Linkages**

Canadian actors frequently borrow language and frames circulating in US conspiratorial ecosystems. Narratives such as "climate lockdowns," "global elite control," or "immigration as environmental destruction" echo talking points developed abroad and are adapted for Canadian debates. This transnational flow blurs the boundary between domestic and foreign influence, enabling denialist rhetoric to circulate widely while appearing to have local legitimacy.

Together, these actors play complementary roles: fringe outlets produce and legitimise content, influencers amplify it across mainstream platforms and messaging applications, while niche communities reinforce it through conspiratorial framing. Their shared function is to erode public trust in science, policy institutions, and democratic decision-making while embedding climate denial and delayism within broader patterns of hate and disinformation in Canada.

# **Adversarial Narratives**

### Summary

The Adversarial Narratives section examines the range of disinformation-driven, conspiratorial, and hostile narratives circulating in Canada's online ecosystem around climate change. While the themes differ, from outright denial of science to claims of economic collapse, the underlying purpose is consistent: to delegitimise the scientific consensus, undermine trust in institutions advancing climate action, and polarise public debate.

Each thematic sub-section outlines how narratives are constructed to portray climate science, policies, and activists as threats to Canadian society. These narratives often recycle long-standing conspiracy theories and ideological tropes, reframing them to suit contemporary political flashpoints such as energy prices, food security, or global governance. They frequently overlap with broader worldviews hostile to government authority, international institutions, or progressive social change. Common frames include portraying climate change as exaggerated or fabricated, depicting climate policies as harmful or authoritarian, and casting activists as extremists or criminals.



The narratives operate within a shared architecture. Disinformation websites, ideologically aligned influencers, and social media accounts amplify these claims, often blending them with other conspiratorial discourses such as anti-globalism, anti-UN rhetoric, or depopulation agendas. This cross-pollination enables climate change denial to appear alongside vaccine misinformation, or critiques of renewable energy to merge with nationalist narratives on energy sovereignty. Such overlap increases reach across audiences and makes the narratives more resilient to fact-checking or moderation efforts.

Examples of these narratives are presented in the accompanying charts using a modified ABCDE framework. This approach captures the actor, behaviour, content, and degree for each case, allowing for consistent comparison across topics and showing how individual incidents fit into the wider information ecosystem. The effect component has been omitted from the charts, as the risks and impacts are described in the broader analysis of each subsection.

Within the ABCD framework, the Degree dimension refers to the visibility and reach of adversarial content. For websites, traffic figures are based specifically on unique visitors from Canadian IP addresses. Website traffic based on Canadian IP addresses does not account for VPN use, meaning users inside Canada may appear elsewhere, and international users may also access Canadian sites. For social media, reach is measured through group size, followers, or interactions such as views, likes, shares, and comments, where such data is available. These metrics do not capture the full circulation of narratives, since content is often paraphrased, copied, or reposted without attribution across platforms. While some posts may have limited direct reach, they are part of a broader ecosystem of amplification. Even low-view material can be shared by larger accounts or migrate to other channels, allowing it to recirculate across multiple audiences. This cumulative effect sustains the visibility and perceived legitimacy of adversarial narratives over time, increasing their capacity to shape public attitudes and behaviours.



### Climate Change Denial and Delayism

### Summary

A 2019 report by the Canadian national climate change assessment body, Canada in a Changing Climate, noted that Canada is warming up twice as fast as the global average.<sup>4 5</sup> Climate change is also creating more favourable conditions for major wildfires, including outside of traditional fire seasons.<sup>6</sup> Despite overwhelming scientific consensus that climate change is real, human-driven, and already affecting Canada <sup>7 8 9 10</sup>, adversarial narratives continue to circulate online.

These narratives seek to cast doubt on the validity of climate science, the reliability of climate models, and the severity of anthropogenic impacts. They often employ pseudoscience, selective reasoning, or misleading historical comparisons to deny or downplay the climate crisis, while simultaneously delegitimising policies aimed at mitigation or adaptation.

In the Canadian digital ecosystem, such rhetoric frequently reframes established climate science as uncertain or manipulated, claiming that there is no consensus among experts or that greenhouse gases such as  $CO_2$  play little or no role in global warming, often claiming climate change is a "scam". By questioning the legitimacy of scientific institutions and modelling tools, these narratives aim to weaken public confidence in evidence-based policymaking. Given the need for climate scientists to operate on multiple models and a vast number of variables when conducting their research, they are often accused of operating on

assumptions rather than real data. Consequently, these claims are often followed by calls for the complete dismissal of climate models, as they are purveyors of false information. These claims frequently overlap with broader conspiratorial claims about elite agendas or globalist manipulation intended to "impose by force", or by undemocratic means, reinforcing climate denial by situating it within a broader adversarial worldview.

The persistence of these narratives is significant not because of the reach of any single post but because of their cumulative presence across platforms and actors. Climate denial and delayism benefit from repetition: claims of scientific uncertainty, the dismissal of carbon emissions, or the portrayal of climate action as unnecessary are echoed and recycled across websites, social media, and commentary outlets. This repetition creates the illusion of legitimate debate where there is scientific consensus, enabling denialist rhetoric to retain influence despite decades of evidence.

The Intergovernmental Panel on Climate Change (IPCC) synthesises and reports on actual scientific consensus to give policymakers an understanding of the causes, effects, and potential solutions to climate change. However, Canadian and international websites question the validity and honesty of the IPCC by depicting it as a partisan, political organisation. The IPCC is regularly accused of falsifying and manipulating the data or rewriting historical climate data to indicate global warming instead of relying on "actual science". Similarly, other international and civil society organisations are also depicted as operating in bad faith due to economic and political incentives, often with the tacit collusion of the "mainstream media."

A second prominent narrative claims CO<sub>2</sub> has little to no effect on climate change. This narrative is often observed in contexts of both climate denial and delayism, usually aimed at disproving the accuracy of climate change predictions or ridiculing the effects of rising temperatures on the weather. Underlying this narrative is the desire to justify the continued large-scale use of fossil fuels and the legitimisation of a desire to maintain lifestyles unchanged. Tied to this is the claim that scientists are unwittingly or intentionally ignoring the authentic sources of global warming, most notably the sun, the reduction of sulphur dioxide levels, or the vast amount of water vapours that make up the majority of GHG. Arguments concerning GHG call into question the impact of CO<sub>2</sub>, resulting in the claim that human impact on the climate is minuscule or non-existent. These claims are often deployed through information-overwhelm<sup>12</sup> <sup>13</sup>

Canadian websites attempt to reverse the so-called "climate agenda" by advancing claims of  $CO_2$  being "essential to all life on Earth".  $CO_2$  is also praised as the driving force behind the rise from poverty and economic development. This often culminates in denials that the increase in temperatures due to  $CO_2$  is harmful. Claims that  $CO_2$  is not harmful also feed into efforts to resist and delegitimise net-zero policies.

The following charts capture examples of these narratives using the modified ABCDE framework. Actor, behaviour, content, and degree are identified for each case, illustrating how disinformation is constructed and circulated. The effect dimension is omitted here, as risks and impacts are analysed in the broader text of this section.

## Climate Change Conspiracy Theories

### Summary

Conspiracy theories play a central role in shaping adversarial narratives on climate change. They move beyond scepticism to allege deliberate fabrication of science, portraying climate change as a hoax designed to advance hidden political or economic agendas. These theories frame environmental challenges not as the result of human activity but as manufactured crises imposed by governments, elites, or secret networks of power. The effect is wholesale distrust in the processes that underpin climate science, policymaking, and institutional legitimacy.

In Canada, conspiracy theories circulate widely across social media and online platforms. They typically claim that international organisations such as the World Economic Forum (WEF) or the United Nations are using climate change to impose control, often tied to the Great Reset or Agenda 2030. Other strands link climate policy to depopulation theories or the New World Order, naming recurrent actors such as the Club of Rome, Big Pharma, the Rothschild and Rockefeller families, Bill Gates, George Soros, and Klaus Schwab. In recent years, these claims have been adapted to portray climate change as a gateway for genocide or selective population reduction.

Extreme weather events, particularly wildfires, are also reframed as orchestrated disasters created by governments or international bodies using geoengineering, directed energy weapons, or deliberate arson. Such theories fuse climate denial with technological paranoia and anti-government anger, turning environmental crises into tools of social control. The wildfire conspiracy is especially prominent in Canada, where destructive fire seasons are blamed on elite manipulation, climate activists, or the High Frequency Active Auroral Research Program (HAARP), rather than ecological drivers.

Together, these theories transform climate change into a battleground for ideological resentment. By linking environmentalism with elitism, deception, and loss of autonomy, they delegitimise climate science, undermine trust in institutions, and promote the idea that environmental catastrophes are manufactured tools of repression. In doing so, they increase the risk of polarisation and radical acts among audiences.

The following charts capture examples of these narratives using the modified ABCDE framework. Actor, behaviour, content, and degree are identified for each case, illustrating how conspiracy theories are constructed and circulated. The effect dimension is omitted here, as risks and impacts are analysed in the broader text of this section.

## Climate Change Policies Are Harmful

### Summary

In Canada, adversarial narratives about climate change policies frame them not as necessary responses to the climate crisis, but as harmful measures that threaten prosperity, sovereignty, and everyday life. These narratives circulate widely across Canadian political discourse, media ecosystems, and online platforms. They rarely arise in isolation: instead, they draw from coordinated disinformation strategies that adapt global tropes of economic ruin, authoritarianism, unreliability, and elitism to the Canadian context.<sup>16</sup>

Economic fearmongering is the most prominent strand. Net-zero targets, carbon pricing, and subsidies for renewables are depicted as "economic suicide" that will devastate households and industries, particularly in provinces with strong carbon-intensive sectors.<sup>17</sup> Narratives exaggerate short-term costs, ignore long-term benefits, and present climate action as a direct assault on Canadian prosperity. This framing resonates across partisan lines and fuels regional grievances, especially in Alberta and other energy-producing provinces, where national climate targets are often cast as hostile to local economic survival.<sup>18</sup>

A second strand positions climate policy as undemocratic or authoritarian, equating Canadian emissions targets and regulatory frameworks with pandemic-era restrictions or technocratic

overreach. Policies are described as imposed by "Ottawa elites" or influenced by international bodies like the UN or WEF, creating the impression that Canadians are being forced into compliance without debate or consent. This authoritarian framing is amplified in far-right and populist digital spaces, where climate governance is portrayed as coercive social engineering that undermines national sovereignty and silences dissent.<sup>19</sup>

Another line of attack questions the reliability of renewable energy in Canada's harsh climate. Wildfire seasons, winter storms, and grid strain events are frequently used as evidence that solar and wind cannot provide stable energy, despite technical evidence to the contrary. In Alberta and British Columbia, wildfire events have been exploited to blame renewable policies for blackouts or rising costs, reframing natural disasters and infrastructure challenges as failures of climate transition.<sup>20</sup> These claims undermine confidence in Canada's energy transition by suggesting that fossil fuels remain the only reliable option.

Finally, climate policy is portrayed as ideologically driven, a partisan project disconnected from ordinary Canadians. In this framing, Canadian environmentalism is presented as a "woke agenda," activists as elitist or hypocritical, and governments as deceitful. Commentators dismiss green policies as performative politics, suggesting they exist to serve globalist interests or political theatre rather than the needs of Canadians. This cultural framing exploits existing political polarisation, painting climate action as a symbolic cause for urban elites that punishes rural or working-class communities.<sup>21</sup>

Taken together, these narratives shape climate policy as a threat rather than a solution, fusing economic anxiety, institutional distrust, and cultural grievance within the Canadian digital ecosystem. They exploit regional divides, moments of crisis, and existing suspicion of elites to delay or delegitimise action. In doing so, they transform climate governance into a flashpoint for broader disinformation dynamics, eroding trust in institutions and obstructing consensus around Canada's environmental commitments.

# Hostility Against Climate Activists

### Summary

In Canada, climate activists face a growing wave of disinformation and hostility that goes beyond criticism of their message to attack their character, motives, and legitimacy. These narratives frame activists as extremists, cultists, foreign agents, or criminals, using language designed to evoke suspicion, resentment, and cultural division. They are not spontaneous reactions but part of a wider disinformation environment fuelled by political opportunism, ideological resistance, and industry-aligned interests. Activists are targeted precisely because they symbolise the push for policies that some perceive as threats to Canada's carbon-intensive economy, regional autonomy, and national identity.

One prominent narrative depicts activists as zealots or members of a "climate cult." In Canadian online discourse, this language reframes environmental concern as irrational fanaticism rather than evidence-based advocacy. Insults directed at public figures, such as calling senior officials or ministers "climate zealots" or "hysterical," strip away policy debate and recast activism as dangerous extremism. Online campaigns amplify this rhetoric, often through memes, coordinated posts, and bot-like accounts, creating the impression of widespread contempt.<sup>27</sup> By presenting climate activism as cult-like, these narratives reduce trust in environmental movements and reinforce political polarisation.

A second cluster of narratives brands activists as eco-terrorists, criminals, or subversives. On Canadian social media, activists are blamed for arson during the 2023 and 2024 wildfire seasons, or described as enemies of civilisation bent on destabilising society. Posts equating politicians or parties with "carbon terrorists" extend the criminalisation frame to democratic governance itself. Such rhetoric often includes calls for imprisonment, reinforcing the view that activism is illegitimate and must be repressed. These claims gain traction during moments of crisis, when disinformation linking wildfires or energy shortages to activist violence circulates widely.

A related narrative portrays Canadian climate groups as agents of foreign interference, echoing the language of Alberta's anti-energy inquiry.<sup>28</sup> Local grassroots organisations are described as fronts for international schemes to undermine Canada's energy sector, despite no evidence to

support these claims.<sup>29</sup> This suspicion delegitimises climate movements, particularly in resource-dependent regions, by framing activism as externally orchestrated and contrary to national interest.

These attacks are not limited to rhetoric; they reflect organised strategies. Research has shown that fossil fuel interests and their affiliates have amplified hostility toward activists through coordinated social media campaigns, influencer engagement, and astroturfing.<sup>30</sup> These efforts harness emotional and identity-based framing to shift debate away from climate solutions and toward culture war politics.<sup>31</sup>

Taken together, these narratives present climate activists in Canada as irrational, extremist, or threatening, undermining their legitimacy and discouraging public support for environmental advocacy. They tap into deep currents of political distrust and regional grievance, transforming climate activism into a target of scorn rather than a vehicle for urgent policy debate. The final overarching aim of these narratives is to leverage broader anti-government and anti-environmental sentiments, portraying activists as threats to liberty.

# Climate Change Intersection with Other Adversarial Narratives

### Summary

In Canada's online environment, climate denial and delay routinely travel with other forms of hate and disinformation. Climate content is used to launder anti-feminist and anti-2SLGBTQIA+rhetoric, to revive antisemitic and anti-immigrant tropes, and to discredit climate advocates through gendered and identity-based attacks in the first cluster of narratives examined. The same posts that call climate change a "scam" also glorify rigid binary gender roles, belittle women and girls in public life, and smear drag performers and queer communities. High-visibility figures are targeted to delegitimise the message through the messenger. Activists like Greta Thunberg are diminished with sexist nicknames and insinuations about competence. Canadian officials and advocates are mocked as zealots or "cultists," and some posts celebrate climate harms, "rooting for climate change" when it will impact marginalised communities. These attacks are not policy critiques. They are identity assaults that aim to push women and gender-diverse people out of the public square.

Another narrative reframes climate policy as a globalist plot. International bodies, political leaders and philanthropies are cast as a hidden cabal that uses climate action to impose a one-world government, population control, or social credit systems. Agenda 2030 and the Great Reset are cited as cover plans to position Canada as a designated relocation zone for "millions" of climate refugees. A petition format is used to braid climate with abortion and "the trans agenda," claiming a single population-reduction scheme. Elsewhere, replacement narratives assert that Canadian "founders" will be swapped for "Third World" migrants under a green banner. Some content imports ideological figures to give this frame an intellectual gloss, citing Eurasianist or "civilizational" thinkers while invoking a "Judeo-Anglo-American cabal."



A third narrative collection is eco-nativism. Immigration is blamed for greenhouse gas emissions and environmental decline, presented as the real cause of Canada's missing climate targets. Posts describe newcomers as "climate-changers," argue that restricting immigration is the only meaningful mitigation, and claim authorities and media conceal this "truth." Variants say Canada cannot meet its commitments while admitting "a half-million climate-changers a year," or that immigration has "a significant negative effect on the environment." These lines borrow the language of stewardship to launder hostility toward migrants, often overlapping with Great Replacement themes.<sup>32</sup>

Together, these narratives recast climate action as a cultural war and should be understood in light of the dissemination of other online harms. They fuse denial of science with attacks on gender equality, queer inclusion, immigrants, and multilateral institutions, eroding trust in experts and public bodies while normalising prejudice. The result is not only policy delay. It is a broader information harm that stigmatises targeted communities and reframes environmentalism as an elite conspiracy against "real" Canadians and a threat to Canada's sovereignty.


